ASSUMED NAME CERTIFICATE

To register a Business Name in Brazoria County, the following is required:

1. You may check business names in the Brazoria County Clerk's Office in Angleton to make sure that someone else is not using the name you have chosen. These names are not protected which makes it important for you to check to make sure someone else has not already chosen this name. You may come into the County Clerks Office located at 237 E. Locust, Ste. 102 in Angleton and search the name yourself at no charge or you may go to our web site at www.brazoriacountyclerktx.gov under land records. You **may not do a search at any of the sub-stations**, as they do not have public computers available. After searching the name, you may complete the online application and come into any office to complete the process or print it from the web site.
**Please print on legal size paper.* You may take the form to a notary for an acknowledgement.
2. An Assumed Name filing is good for ten (10) years from the date of recording. The breakdown of the filing and copy fees are listed at the bottom of this letter. Money order, personal checks, company checks (made payable to Joyce Hudman County Clerk) or credit cards (MasterCard, Visa, & Discover).

\$27.00 for 2 page document w/one owner
\$ 0.50 for each additional owner

\$6.00 for 1 page certified copy
\$7.00 for 2 page certified copy
\$1.00 for 1 page plain copy
